MHC is open from 1-3PM on Monday, Tuesday, Wednesday, Friday and Saturday. MHC provides 3-4 days' worth of emergency food, once per month. The exception is people without cooking facilities, who are able to come weekly and receive a smaller portion. Food is obtained through donations of food or money from individuals, through grants from several community organizations, and through the Federal government's TEFAP (The Emergency Food Assistance Program), which gave us nearly 190,000 pounds of food in 2014. We are also able to purchase some food at a good price (18 cents/pound) from the Central & Eastern NC Food Bank when it is available. We also have quarterly food drives where volunteers ask for donations at local grocery stores.

During 2014 MHC served 36,312 individuals. There were 15,331 families. 9,048 were children under 18; 4,949 were between 55-65 years of age; and 3,156 were over 65. Individuals with no stoves totaled 1,786. 1,800 were Veterans and 2,026 were diabetics. A total of approximately 654,000 pounds of food was distributed to clients in 2014.
