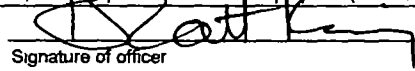

We facilitate Christian mission and social work activity in Alaska through the use of volunteers. We manage the logistics and ministry for the visiting church teams, school groups and individuals. This year we also did work in Romania and Kenya

We hosted 1260 volunteers in 2014 - a 23% increase over 2013, and 105% increase since 2012. This included 85 church and school groups in 2014. We had teams serving approximately 10 Alaska locations each week for ten weeks in the summer - Monday through Friday every week serving in Anchorage, Kenai, Soldotna, Wasilla, and Palmer. Teams did sports, games, crafts and Bible school with the children. Literally thousands of children and youth have had their summer blessed, and learned of God's love for them. Many chose to follow Christ. We hosted approximately 100 community evening evangelistic park parties. Our partner churches and church planters have started several small groups at our ministry locations that continue after the summer is over. We fed 11,350 free meals in the parks to disadvantaged, hungry children - meals funded by God, not the Government. Also, 40 of the children from the parks where we worked attended the GraceWorks camp in Wasilla this past week. We also facilitated seven weeks of volunteer teams serving in remote Alaska Native villages. Program expenses include all team food expenses, housing expenses, local transportation

Overseas, we took a medical team to Kenya working with AIDS orphans, and also took a dental/evangelism team to Romania. These involved 26 people. Expenses included plane tickets, insurance, ground costs (food/housing/transportation). Also included here is 10% of Scott Kirby Salary package since he organized and led these teams. We also made gifts of \$2500 total to Romanian church workers.
