(BPI) initiated the RGPC in California in 2013. The BPI institutes consist of 6, 4 day trainings on a quarterly basis. Continuing the RGPC in 2014, BPI held 4 quarterly trainings for 19 participants, diverse in terms of race, age, sexual orientation, class, religion, etc. These participants receive extensive training in the Be Present Empowerment Model (R) and are responsible to work together to plan a national RGPC Conference to be held in 2015. The youngest active participant is three years old. The oldest is 81.

The RGPC provides a safe space for participants to gain insight into and understanding of how issues, such as race, gender, power and class,

CONSULTING SERVICES TO NPO'S - BPI provided consulting services to the following NPO'S in 2014: (1) BPI continued its work with the Pittsburgh Community in downtown Atlanta. Pittsburgh is a low-income community that is part of the Annie E. Casey Foundation Atlanta Civic Site Program. BPI provided training and consultation to the Pittsburgh Neighborhood Resident Leadership Team and the Casey Foundation liaison, using the Be Present Empowerment Model(R) to strengthen the Team and to develop an effective community organization. (2) BPI also worked with Harvest Time, Inc. Harvest Time, Inc. invites Christians of wealth to come together in circles to engage with money as the doorway to spiritual transformation at personal, communal and systemic levels to work for social justice and fairness. BPI worked with, and continues

BLACK & FEMALE LEADERSHIP TRAINING INITIATIVE (B&FLI) - The B&FLI is a 5-year initiative launched in 2013 that demonstrates the leadership of Black women in partnering with diverse people to create sustainable change that serves everyone in our communities. In 2014, there were three, 4-day trainings of the Leadership Team (train-the-trainers). This team is comprised of 11 Black women. This team will take the lead in implementing an intensive 18-month Black and Female Leadership Institute that establishes a community of practice in using the Be Present Empowerment Model(R) to build trust and relationships between black women and girls of all backgrounds, strengthen their collective leadership skills, and increase the visibility of the leadership of Black women and girls in diverse social justice movements.

2. CHILDREN'S LEARNING AND PLAY - The Children's Learning and Play

program is an important program in BPI. Children of all ages participate in all BPI events and programs, but we recognize that, in addition to participating with teens and adults, younger children need time to rest, play and have separate time with each other. Trained Children's Learning and Play facilitators and trainers move with the children from the main program into the Children's Learning and Play areas, where the children learn about the Be Present Empowerment Model(R) and practice using it when issues arise among the children. They also have time to play.

3. MONTHLY REGIONAL ORGANIZING CORE GROUP MEETINGS - The BPI local

5. NATIONAL NETWORK LEADERSHIP CONVENING AND TRAINING - In November of each year, BPI conducts the National Network Leadership Convening and Training (NNT) for people in the BPI national network. Approximately 40 people attended in 2014. The purpose of the NNT is to review accomplishments made during the year, review and update the national development plan, share information concerning regional development, and further train participants in the Be Present Empowerment Model(R) and leadership development.
