| In 2014 The Mississippi Center for Nonprofits (the state's only nonprofit management center) offered over 50 nonprofit focused trainings designed to help nonprofits operate better. One of the greatest obstacles facing the nonprofit sector in Mississippi is a lack of capacity due to limited resources, staffing, management expertise and leadership. For over 23 years the Center has provided sessions focused on key areas such as grant writing, legal compliance, financial management and fiduciary responsibilities of volunteer boards. In 2014 these trainings were attended by over 600 individuals, representing over 300 agencies from across the state. The Center's grant-seeking and fundraising sessions helped contribute to the estimated \$9 billion brought into the state by the nonprofits sector of Mississippi. Augmenting the Center's efforts is the fact that it has close ties and partnership with a wide range of foundations, state agencies, community colleges, United Ways, CDC's, consultants and other capacity building organizations. The Center continues to provide member services to over 300 nonprofit members. Providing free access to Grant Station (on-line research engine), subscriptions to nonprofit management publications and cost-saving discounts in insurance, office supplies and website design. While at the same time providing consulting and information assistance - answering over 1,000 calls from nonprofits members and hundreds of other grassroots constituents from across the State. The Center's Excellence in Action Nonprofit Certification Program (EIA) is a high-level educational program that was designed specifically for nonprofit executives and board members based on best practices for nonprofit management. EIA has already had a great impact on Mississippi nonprofits. In the past four years, over 285 people earned individual certification and 32 organizations received the Excellence in Action Certification. After attending our programs, individuals are able to demonstrate the knowledge and skills required to establish and/or manage a strong and effective organization. The mission of the Mississippi Center for Nonprofits is to strengthen the capacity of nonprofits that serve the people and communities of Mississippi. The Center works with organizations all across the state through on-going nonprofit management training workshops, events and certification programs. The topics for the Center's workshops are defined in the Center's Principles and Practices of Nonprofit Management: Planning and Purpose, Board Governance, Human Resources, Financial Management, Transparency and Accountability, Fundraising, Public Policy and Advocacy, Information and Technology, Strategic Alliances and Programmatic Effectiveness. These workshops are tailored to meet each organization's needs and can be beneficial regardless of the level of knowledge and expertise in the nonprofit organization. |         |                      |                        |                      |
