The Truancy Intervention Project ("TIP") was organized by the Atlanta Bar Association in response to the growing truancy problem in Fulton County Its objective is to provide early, positive intervention with children in Atlanta Public and Fulton County Schools who are chronically absent from school and as a result, either become involved with the Fulton County Juvenile Court or are referred for early intervention at the school level By pairing trained volunteers with children and their families, TIP strives to decrease absenteeism rates and provide families with resources and services necessary to ensure success in school During the 2013-14 school year, TIP served 384 students in the Atlanta and Fulton County Public School systems These children were served by served by 181 active volunteers who collectively donated 6,022 hours of time to TIP Since inception in 1991, TIP has received over 9,000 referrals with an overall success rate of 85%
