Social Services Operating Grant See Schedule O Social Services Operating Grant Expenses \$457,021, including Grants of \$457,021 The Foundation made a grant to support the operations of the Social Services Department of the Thompson Cancer Survival Center In 2014, the Social Services Department reported 1,549 new patients and 4,054 follow-up patients Additionally, 1,008 new patients and 3,973 follow-up patients were provided with nutritional counseling and education The Social Services department includes a Genetics Clinic staffed by two licensed and certified genetic counselors who provide breast cancer and hereditary cancer risk assessments and who coordinate genetic testing In 2014, the Genetics Clinic counseled 292 new patients, including 224 who pursued genetic testing Of those, 17% tested positive for a hereditary cancer syndrome Whether patients tested positive or negative for a hereditary cancer syndrome, decided not to pursue testing, or were not appropriate candidates for testing, they and their families were able to make informed decisions regarding their medical management based on the genetic counseling they received

Clinical Trials Operating Grant See Schedule O Clinical Trials Operating Grant Expenses \$247,163, including Grants of \$247,163 TCSC Foundation provides an operating grant to the Thompson Cancer Survival Center for its Clinical Trials program Since the opening of TCSC in 1988, the Clinical Trials Department has enrolled 2,283 patients in clinical trials The TCSC Clinical Trials Department currently has 15 active treatment patients and 206 patients in follow-up In 2014, TCSC Clinical Trials Department enrolled 21 patients to oncology clinical trials Increased efforts have been made to send TCSC nurses to Methodist Medical Center, Blount, Sevier and Parkwest tumor board meetings To help with screening efforts, Research Nurse Coordinators are assigned to specific physician schedules for screening and to specific locations for coverage, including TCSC's Oak Ridge, Sevierville, West Knoxville, and Blount sites Opening new studies increases referrals locally and regionally and gives current patients the ability to be treated with state-of-the-art care in their own community Involvement in prevention and treatment trials offers an improved means of health strategies for individuals at risk for certain cancers, as well as access to proven standard cancer treatments and new, developing cutting edge therapies for those diagnosed with cancer

Multidisciplinary Operating Grant See Schedule O Multidisciplinary Operating Grant Expenses \$166,871, including Grants of \$166,871 Multidisciplinary Treatment facilitates specialty physicians discussing treatment options based on the individuality of one's circumstances The Multidisciplinary Cancer Care Coordinator schedules a private consultation for each patient with the members of the specialty team This approach affords the opportunity for the physician to relate one-on-one with the patient and explain treatment choices in layman's language In 2014, 331 breast patients were under conference discussion and 101 were seen in clinic, 249 chest patients were under conference discussion and 47 were seen in clinic, and an additional 360 general tumor patients and 5 neuro cancer patients were discussed in conference

The purpose of the program is to help ease the path for new patients by giving each of them a thoughtful basket filled with products to help them through their journey. Chemotherapy can produce many and varying side effects and no two patients react the same. By providing the comfort care basket at the start of treatment we help prevent some of the unknown by preparing our patients with trusted items that will make their journey a bit easier. The baskets include items such as Biotene products, lip balm, lemon hard candies, hand sanitizer, antibacterial hand soaps and wipes, a soft toothbrush, a turban, footies, books of encouragement and a journal to record their thoughts and experiences. In 2014, 300 baskets were distributed.
