RESEARCH THE ALR ENGAGES IN ACTIVE GRANT MAKING MANAGEMENT, WORKING HAND-IN-HAND WITH INVESTIGATORS TO GUIDE AND DRIVE THE RESEARCH PROCESS (SEE SCHEDULE O) SINCE ITS INCEPTION, THE ALR HAS COMMITTED NEARLY \$97 MILLION TO FUND LUPUS RESEARCH PROJECTS IN 2014, NEW GRANTS TOTALING \$8 3 MILLION WERE AWARDED TO 15 INVESTIGATORS WITH PROMISING NEW AVENUES OF RESEARCH UNDER THE TARGET IDENTIFICATION IN LUPUS (TIL) THREE YEAR GRANT MECHANISM IN 2005, THE ALR LAUNCHED A GLOBAL CONSORTIUM OF LUPUS RESEARCHERS MEMBERS OF THE INTERNATIONAL SLE GENETICS (SLEGEN) CONSORTIUM POOLED THEIR RESOURCES AND INTELLECTS, DETERMINED TO FIND THE GENES RESPONSIBLE FOR LUPUS THE PROJECT WAS ORIGINALLY SUPPORTED BY \$2 5 MILLION IN FUNDING FROM THE ALR IN 2010, AN ADDITIONAL \$500,000 WAS AWARDED TO THE SLEGEN CONSORTIUM FOR AN IMMUNOCHIP PROCESS GEARED TOWARD UNDERSTANDING THE GENETIC BASIS OF LUPUS IN DIVERSE POPULATIONS AND WORK IS CONTINUING TO BE DONE TO ANALYZE THE CONSORTIUM'S DATA RESULTS ARE EXPECTED TO BE PUBLISHED IN 2015 ALR'S UNIQUE FUNDING MODEL SUPPORTS PROMISING RESEARCH EFFORTS WITH THE GOAL OF IMPROVING THE LIVES OF PEOPLE WITH LUPUS IN THE NEAR FUTURE THROUGH A COMPETITIVE PEER-REVIEW PROCESS AND AN INNOVATIVE VENTURE-CAPITALIST APPROACH, PROJECTS BY THE ALR AIM TO TRANSLATE RESULTS FROM THE RESEARCH BENCH TO THE BEDSIDE BECAUSE THE ALR'S BOARD OF DIRECTORS FUNDS ADMINISTRATIVE AND FUNDRAISING EXPENSES, 100% OF ALL OTHER CONTRIBUTIONS GOES TO SUPPORT THE ALR'S LUPUS RESEARCH PROGRAMS

SCIENTIFIC PROGRAMS THE ALR ENCOURAGES CROSS-SECTOR AND CROSS-DISCIPLINE PARTNERSHIPS TO FOSTER AN INNOVATIVE RESEARCH ENVIRONMENT IN 2014, THERE WERE COLLABORATIVE MEETINGS FUNDED BY THE ALR WHERE RESEARCHERS WERE ENCOURAGED TO EXCHANGE IDEAS AND HELP THE ALR TARGET NEW RESEARCH OPPORTUNITIES THIS INCLUDED SCIENTIFIC ADVISORY BOARD MEETINGS, OUT OF WHICH CAME SUPPORT FOR CONTINUING THE ALR'S TARGET IDENTIFICATION IN LUPUS GRANT PROGRAM, CONTINUED SUPPORT FOR THE SLE GENETICS CONSORTIUM AND ENCOURAGING PARTNERSHIPS AMONG INVESTIGATORS, PHARMACEUTICAL AND BIOTECH COMPANIES AND FOR CLINICAL TRIALS (SEE SCHEDULE O) DRUG REPOSITIONING THE ALR IS EMBARKING ON A MAJOR NEW CAMPAIGN THAT WILL RADICALLY SHIFT THE THINKING ABOUT HOW EXISTING MEDICINES ARE UTILIZED THE GOAL IS TO OPEN UP NEW AVENUES OF TREATMENT FOR PEOPLE WITH LUPUS THROUGH AN EFFORT CALLED "DRUG REPOSITIONING" AND ACCELERATE THE PACE OF IDENTIFYING NEWER, SAFER, AND BETTER TREATMENTS FOR LUPUS PATIENTS ALR HAS EVALUATED ALL OF THE FDA APPROVED MEDICINES FOR 6,800 DISORDERS IN ORDER TO ASCERTAIN WHETHER SOME OF THESE MEDICINES USED TO TREAT OTHER CONDITIONS MIGHT BE EFFECTIVE IN TREATING LUPUS THERE ARE MANY ADVANTAGES TO OUR DRUG REPURPOSING STRATEGY THESE ADVANTAGES INCLUDE SAVING TIME TO DEVELOP NEW THERAPIES, SAVING COSTS ASSOCIATED WITH DEVELOPING NEW MEDICINES, SAFER OUTCOMES BECAUSE ALREADY APPROVED MEDICINES HAVE A WELL-ESTABLISHED SAFETY PROFILE, MINIMIZING THE NUMBER OF TRIALS AND PARTICIPANTS NEEDED TO GET A MEDICINE APPROVED, AND POTENTIALLY, FAR MORE EFFECTIVE TREATMENTS FOR PEOPLE WHO SUFFER WITH LUPUS AS A RESULT OF OUR INITIAL SCREEN WE HAVE IDENTIFIED APPROXIMATELY 100 DRUGS (AND OTHER TREATMENTS) CURRENTLY BEING USED TO TREAT OTHER CONDITIONS THAT HAVE A GOOD LIKELIHOOD OF BEING EFFECTIVE TREATMENTS FOR LUPUS ALR'S UNIQUE FUNDING MODEL SUPPORTS PROMISING RESEARCH EFFORTS WITH THE GOAL OF IMPROVING THE LIVES OF PEOPLE WITH LUPUS IN THE NEAR FUTURE THROUGH A COMPETITIVE PEER-REVIEW PROCESS AND AN INNOVATIVE VENTURE-CAPITALIST APPROACH, PROJECTS BY THE ALR AIM TO TRANSLATE RESULTS FROM THE RESEARCH BENCH TO THE BEDSIDE THE NEXT PHASE IS TO TRULY ASSESS THE "BEST OF THE BEST" OF THESE ALREADY FDA APPROVED MEDICINES FOR THEIR ABILITY TO TREAT LUPUS TO DO THAT, ALR WILL RUN "PROOF OF CONCEPT" CLINICAL TRIALS TO EVALUATE WHETHER THESE MEDICINES IMPROVE THE OUTCOME IN PATIENTS WITH LUPUS WE WILL BE BUILDING ALLIANCES AND PARTNERSHIPS WITH COMPANIES, ORGANIZATIONS, AND INDIVIDUALS WHO ARE WILLING TO ASSIST ALR IN REALIZING THE GREAT POTENTIAL OF THIS PROGRAM OVER THE NEXT 5 YEARS WE WILL RUN MULTIPLE CLINICAL TRIALS WITH MEDICINES THAT LOOK THE MOST PROMISING IN 2015 ALONE WE EXPECT TO INITIATE 4 "PROOF OF CONCEPT" CLINICAL TRIALS IN APPROXIMATELY 30-40 TRIAL SITES THROUGHOUT THE UNITED STATES THE ALR IS IN THE PROCESS OF RECRUITING THE VERY BEST CLINICAL TRIAL SPECIALISTS IN LUPUS TO RUN TRIALS HAND IN HAND WITH THE ALR OUR CONSORTIUM WILL CONSIST OF APPROXIMATELY 50 - 60 CLINICAL CENTERS WHICH WILL EXECUTE THE TRIALS UP TO 90% OF THE PEOPLE WITH LUPUS ARE WOMEN AND THE DISORDER IS THREE TIMES MORE PREVALENT IN AFRICAN AMERICAN WOMEN THAN ANY OTHER GROUP PATIENT RECRUITMENT WILL BE THE MOST CRITICAL ELEMENT IN THE SUCCESS OF THIS PROGRAM
