Part III Statement of Program Service Accomplishments

4a The Southeastern Regional Genetics Group, Inc held its annual meeting July 17-19, 2014, at the Sawgrass Marriott Hotel in Ponte Vedra Beach, Florida. Approximately 178 healthcare professionals with an interest in Genetics attended. Twenty-eight platform and twenty-four poster presentations were made covering current issues in all areas of genetics: molecular genetics, cytogenetics, biochemical genetics, and clinical genetics. Highlights included presentations on the LEND network, Disorders of amino acid metabolism, the Challenge of Integrating Genetics into Primary Care Pediatrics, MRI Manifestation of Genetic Disease, Evaluation of Behavior, Executive Function, Neurotransmitter Function and Genomic Expression in PKU, Inflammation is Associated with High BMI and Low Bone Turnover in Phenylketonuria, Elevations of Urine Keratan Sulfate are not Limited to Patients with Morquio Syndrome, Newborn Screening in the Genomic Era, Genetic Clinic in the 21st Century, Rett Syndrome Lessons from the Natural History Study, The Clinical and Molecular Complexity of Split-hand/foot Malformation, and Diagnosing the Previously Undiagnosable through Genomic Medicine. The Consumer Alliance group meetings included discussions on empowering advocates and connecting consumers, strategic communication strategies and state updates, financial and estate planning, medical home and transitioning, emergency preparedness, an update on medical food equity act, and the Affordable Care Act Project and its impact on consumers.

4b Key healthcare providers in the SERGG region (Alabama, Florida, Georgia, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, Puerto Rico and the US Virgin Islands) met on several occasions to continue the work begun in 2004. This included workgroup meetings to continue the development of guidelines of standardized practices for healthcare professionals on the treatment of patients with inborn errors of metabolism.
