The Organization contracts with 17 providers to offer a wide range of services to clients. This contract provided 8,958 unduplicated older persons and caregivers with services during 2014.

The Alzheimer's Disease Initiative program ensures that persons afflicted with Alzheimer's disease and other forms of dementia, are given essential services to help them age in place, in an elder-friendly environment, with security, dignity, and purpose.
