THE FOUNDATION PLAYED A KEY ROLE IN SECURING HISTORIC LEVELS OF FUNDING FROM THE STATE OF FLORIDA FOR EVERGLADES RESTORATION PROJECTS, INCLUDING CONSTRUCTION OF THE NEXT PHASE OF TAMiami TRAIL BRIDGING. THE FOUNDATION SUPPORTED THE AUTHORIZATION AND IMPLEMENTATION OF THE CENTRAL EVERGLADES PLANNING PROJECT, A COMPONENT OF THE COMPREHENSIVE EVERGLADES RESTORATION PLAN THAT WILL SEND WATER SOUTH INTO THE EVERGLADES.
