Hockey Camps - Lightning Made Hockey is designed to give hockey players of all ages and skill levels the opportunity to experience, learn, and enjoy the game of hockey through a series of camps and clinics held year round While all Lightning Made programs utilize USA Hockey's American Development Model to focus on basic skill development, each program exudes its own unique experience while enhancing various aspects of a player's game Lightning Made Clinics are focused on the entry level hockey player, with an emphasis on the absolute fundamentals The Lightning Made Alumni Series is directed at the beginner to intermediate hockey player who is looking for help on certain aspects of his or her game including defensive skills, offensive and stick handling skills, and goaltending The Lightning Made Summer and Holiday Camps target hockey players of all skill levels who are looking to round out their overall game The Lightning Made Training Camp is an elite level program targeted at the higher caliber player as the hockey season approaches, and gets them back in game shape All programs utilize the best instructors you could possibly find, individuals that have been around and know the game of hockey, former NHL and college level players
