THE FPGO PROGRAM PARTNERS WITH 24 LOCAL FAITH CONGREGATIONS, OF ALL DENOMINATIONS, TO SHELTER FAMILIES WITHIN CONGREGATION FACILITIES STAFFED BY TRAINED VOLUNTEERS. OUR IN-KIND DONATIONS OF VOLUNTEER TIME, SHELTER FACILITIES AND MEALS WERE VALUED AT \$408,542 FOR 2014. PROFESSIONAL STAFF PROVIDES CASE MANAGEMENT, LIFE SKILLS TRAINING AND SUPPORT SERVICES TO ASSIST THE FAMILIES IN REGAINING THEIR INDEPENDENCE.
