Food, Clothing, and Shelter Programs - The Organization operates an orphanage for more than 100 Haitian children Through the orphanage, the children receive clothing, school uniforms, shelter, and three meals a day The Organizations Feeding Program serves more than 16,000 meals each month through the school lunch program, orphan-care program, and the community feeding program A 186,000 gallon cistern and a clean water program provide clean drinking water in tandem with the Feeding Program In 2013, the Organization completed the construction of eight new orphan-care homes Each home operates independently as a household with 12-15 children Children that had been living on the campus in temporary shelter since the earthquake in 2010 moved into these new homes in 2013 We are continuing to see the fruit of our labor in building these homes, as they have dramatically improved the lives of the children and allow the house parents to provide a family-type setting for each child

Acadmic and Educational Programs - The Organziation operates a private non-denominational school for almost 300 children from preschool through the final year of high school Approximately two-thirds of these children come from the surrounding village of Ouanaminthe The Organization provides school supplies, books, uniforms, and medical care for each of the children attending school The educational and academic programs allow the Organization to prepare the children attending school The educational and academic programs allow the Organization to prepare orphaned and impoverished children for a promising future by providing quality educaion and leadership skills In 2014, the Organization continued to improve its newly implemented official sports program, allowing the children to participate in competitive sports such as soccer and volleyball Additionally, the Organization celebrated the high school graduation of its first two children and continued to help them with preparations for continuing education at the collegiate level

Medical Care and Assistance - The Organization assists in the provision and procurement of medical care for impoverished children in Haiti through 1 The Medical Center, a newly constructed three-story pediatric medical center, opened in 2013 It currently offers primary outpatient medical care and health education five days each week to the village of Ouanaminthe 2 The Baby Rescue Program which provides assessment and treatment for malnourished babies and toddlers with medical-grade nutritional supplements on a weekly basis 3 The Recreational Therapy Program which assists children with special needs and/or physical disabilities, and educates the families on properly caring for their children 4 The Dental Clinic which provides dental care, education, and dental care supplies for impoverished children in Haiti

The Ministry's position that it is tax exempt under Section 501c3, and the position that none of its income is unrelated business taxable income are defined as tax positions under these requirements. While management believes it has complied with the Internal Revenue Code, the sustainability of some income tax positions taken by the Ministry may be uncertain. There are minimum thresholds of likelihood that uncertain tax positions are required to meet before being recognized in the financial statements. Management does not believe that the Ministry has any material uncertain tax positions at December 31, 2014. In the event interest and penalties were due relating to an unsustainable tax position, they would be treated as a component of income tax expense. The Ministry's federal income tax returns are subject to examination by the Internal Revenue Service, generally for three years after filing. At December 31, 2014, the tax returns for the years 2011, 2012, and 2013 are subject to examination.
