The community center building has ample common space. This allows island residents to come together informally, as well as for planned social gatherings such as dinners and dances. Cultural and entertainment events including dance and music performances, lectures, films and workshops are also held in the main hall of the community center. These uses of the building provide opportunities for recreational, educational, and healthful social interactions among island residents as well as access to the arts.

The community center building includes a cafe, an informal gathering spot with Wi-Fi access. The Cafe provides a place for residents to enjoy fresh food and coffee, connect to the internet, and get caught up with one another, thus promoting social interaction in support of the community.

(Code) (Expenses \$ 42,253 including grants of \$) (Revenue \$ 34,341)

The community center building houses a Fitness Center where a variety of exercise classes are offered, including classes targeted toward older island residents. In addition, exercise equipment is available on a membership basis. Fees are set to cover costs of equipment, and reduced fees/extended payment plans are available for community members needing assistance. Also within the fitness center is a space available for rent by private specialists coming from the mainland to offer physical therapy, counseling, and other services to residents. The availability of health and fitness activities promotes the physical and emotional life of the island residents, particularly during the challenging winter months, providing further support for the year-round community.
