OUTREACH SERVICES: (Chapel services, meals and clothes, housing and employment counseling, life skill training, case management, and health clinic services):

Outreach services are designed to help people lead productive and meaningful lives. Relationships and trust are often built through compassionate care. (In 2014, 42,006 meals were served to the hungry, and 600 people were given items of clothing.) People are connected to the resources they need through personal contact with a counselor. (Provided resource referral and case management services for 1,563 people.) Health barriers are overcome through access to a free health clinic. (Provided 444 free medical visits.) Jobs for Life classes teach the unemployed and underemployed how to successfully find and keep employment. A search for jobs and housing is aided by the use of a computer lab and tutors. (70 people were prepared for employment through Jobs for Life classes.) Spiritual and emotional growth is fostered through chapel services, small groups, and pastoral care (1,135 client sessions were provided.)

TRANSITIONAL SERVICES: (Residential services for men and women in transition):

Transitional living helps men and women who find themselves homeless for a variety of reason to temporarily live in a safe, supportive, and accountable living environment while they find work, save money, and practice healthy living skills, and prepare themselves for moving into permanent housing. The Potters House, located on North Limestone Street, is a residential facility for men in transition that houses up to fourteen residents and a house coordinator. In 2014, the Jeremiah House for men was merged with the Potters House, and the Ruth Home for women was closed. There were 3,274 nights of lodging and care provided to 44 men and women in 2014.

HOMELESS PREVENTION: (Emergency financial assistance for rent, utilities, and other basic needs):

Many people have little or no extra money to weather the storm when there is an interruption to income or expenses. Without help, they can easily become homeless. A housing counselor meets one-on-one with families to administer financial assistance to families facing a crisis. Rental assistance of \$ 21,520 was provided to 82 families to help prevent eviction. Utility bill assistance of \$12,750 was provided to 80 families to help prevent utilities from being shut off. Other assistance was provided for transportation (\$1,276), prescriptions and lab fees (\$8,466), and other varied forms of assistance, including back-to-school clothing for kids, (\$11,188).

supporting documentation. Applications are reviewed and approved by a supervisor. The Executive Director approves payments and signs checks made payable directly to the landlord

or utility company on behalf of the client. Patient prescriptions are written by the nurse practitioner manager or volunteer and are processed and invoiced through a single pharmacy

vendor. Local bus passes and gas cards are purchased in advance by each respective Division Director. These passes and gas cards are distributed to eligible clients according to

need. Other assistance includes helping clients secure identification cards and copies of birth certificates so they can obtain employment. A case manager personally interviews clients

and assesses their need for help. In some cases payments are made online by credit card, and in other cases payments are made through a requisition for petty cash. Each purchase is

recorded by the case manager on a spreadsheet with identifying information, type of assistance and the amount.

Part III, Line 3: The thrift store, located at 720 Bryan Ave, was closed in August 2014 due to excessive financial operating losses. Also, transitional living for men was consolidated at the Potters House on North Limestone St. and the Jeremiah House was vacated. The Ruth Home for women suspended its services in early 2014 and was vacated in June.

Part III, Line 4d: THRIFT STORE AND VOCATIONAL TRAINING (The organization operated a thrift store located at 720 Bryan Ave., Lexington, KY). The store was closed August 2014 due to excessive losses. Most of the revenue of the store was from the sale of used merchandise donated to the organization. The store is operated by employees. Supervised trainees and volunteers supplement the work. Clothing vouchers issued through the organization were fulfilled at the store before it was closed. The organization entered into an agreement with Goodwill to honor all of the clothing vouchers it issues to its clients at any of the area Goodwill Store, and the organization will reimburse Goodwill for the value of merchandise redeemed.

Part VI, Line 11b: Officers and directors are sent a copy of the Form at least 10 days in advance of the filing deadline date with instructions to review and direct questions and comments to the Executive Director prior to submission.

Part VI, Line 12c: Officers, directors, and key employees annually complete a questionnaire that is reviewed by the board to determine the extent, if any, of any real, perceived, or potential conflicts of interest. The board will periodically review and update its Conflict of Interest Policy.

Part VI, Line 15a: The Executive Director's compensation is approved by the organization's board each year. Comparable compensation data is reviewed by the Board's Compensation Committee, and the Committee presents its findings and recommendations to the full board for its approval, which is documented in the Board's Minutes.

Part VI, Line 19: The organization makes copies of its articles on incorporation, bylaws, conflict of interest policy, and financial statements available upon request. In addition, the last two years of audited financial statements, Form 990's, and Annual Reports are posted on the organization's website. There are also links on the website to GoodGiving.net, Evangelical Council of Financial Accountability (ECFA), GuideStar, and GreatNonprofits, which all have profiles of the organization.

Part XII, Line 2e: The oversight process and selection process of an independent accountant to perform the audit is now delegated to the Treasurer of the organization, rather than an audit committee. The Treasurer presents his selection recommendation to the board for its approval. The Treasurer signs the engagement letter, discusses progress as needed during the audit, and invites the independent accountant to present the financial statements to the entire board upon completion of the audit.
