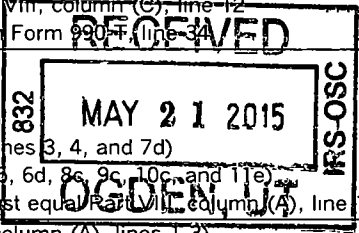

Reach High Educational and Pre-Vocational Day Program is for students with intellectual disabilities who are no longer in school, age 18 and above. This is a year-round program conducted Mondays through Thursdays. Reach High has a maximum enrollment of 15 students which continues at capacity with a waiting list. This program provides extended opportunities to reinforce education and social skills as well as to provide pre-vocational training. Students maintain and enhance skills learned in school (such as reading and math) and gain new skills in an environment stressing teamwork and positive interactions with peers, teachers, and guests.

4b (Code) (Expenses \$ 62,317. including grants of \$ 35,600.) (Revenue \$ 9,838.)

Afternoon Enrichment Classes are designed for individuals with intellectual disabilities age eight and above. There are six 6-week sessions with 50 students participating in one or more classes. Sixteen weekly classes are offered for recreation, life skills, arts and crafts, and academic enrichment. Recreational classes stress teamwork while improving coordination and health. Cooking classes, computer classes, and the popular CSI class add to life skills while other classes such as reading, community-based math, and Bible adventures provide academic enrichment. Classes in fine arts provide an opportunity for self expression and relaxation. An underlying purpose of each class is the social development of the individual including communication skills, following directions, and encouraging positive interactions with other students, teachers, and volunteers.

4c (Code) (Expenses \$ 8,981. including grants of \$ 2,500.) (Revenue \$ 2,695.)

Summer Camps and Art Classes were conducted over three weeks in 2014. A one-week summer camp focused on children age six through eleven. There was a limit of 12 participants to give individual attention. Our young "Villagers" kept busy with fun activities, crafts, and a focus on social interaction. A two-week camp was conducted for 40 secondary students age 12 and above. The "Back to Nature" theme incorporated traditional day camp activities such as water play, crafts, drama groups, and competitions among the four teams of ten for individual and camp awards. The summer art classes are conducted by a professional artist and highly skilled volunteers. By following directions closely, "Villagers" produce art on canvas suitable for framing and gift-giving. Some works of art are given to High Point Village donors or presented at fundraisers for sale.
