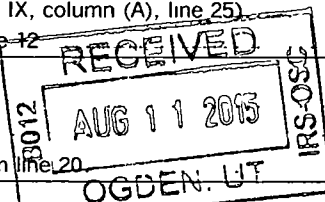

Significant changes to the organization's bylaws included changing the mission of the organization. The previous mission stated "Vision 2.0 Technology is organized exclusively for the charitable and educational purposes of providing technological assistance to non-profit organizations, community organizations, and small businesses, in order to improve their ability to harness modern technology to achieve their charitable missions, create economic opportunity, and advance the public good." The amended bylaws broaden the mission of the organization, stating "Southern Vision Alliance is organized exclusively for the charitable and educational purposes of providing assistance to non-profit organizations and community organizations in order to improve their ability to achieve their charitable missions and advance the public good." The amended bylaws also removed the requirement that full-time staff be invited to join the board, changed the meeting requirement to one per year, added a procedure for electing board officers, and removed the requirement that all staff be paid the same amount.
