Pt VI, Line 12c Any conflict of interest, through transaction, contract or
employment, between any Board Member, Administrator, or
family member of the Board Member and Hearthside, Inc.
will be disclosed to the Board of Directors prior to
consummation of said transaction, contract or employment.
The Board of Directors shall approve and record their
approval of such transaction, contracts or employment in
their written minutes. Annually, the Board shall review
any previously approved conflicts of interest.
