NASHVILLE ZOO RANKED IN 2014 AS ONE OF THE TOP PAID ATTRACTIONS IN MIDDLE TENNESSEE AND WAS ALSO ONE OF THE MOST VISITED ATTRACTIONS IN THE STATE. ZOO MEMBERSHIP ALSO HIT A HIGH OF 36,793 HOUSEHOLDS WHICH REPRESENTS MORE THAN 156,000 PEOPLE. APPROXIMATELY 52,000 SCHOOL CHILDREN VISITED THE ZOO IN 2014 AS PART OF THEIR EDUCATION CURRICULUM, OF WHICH 8,384 OR 16% CAME FROM METRO NASHVILLE TITLE I SCHOOLS.
