shipped to Chad, Haiti, Honduras, Liberia, Madagascar, Panama,
Philippines, Tanzania, and Zimbabwe. HHI sent food, water, and on medical
supplies to South Sudan to bring relief from war and famine. In the
Philippines the relief effort in response to Typhoon Yolanda continued
HHI sent medical aid to Liberia in the fight against Ebola.
Ishinomaki, Japan - provided basic necessities of food, clothing, and
clean drinking water. Hundreds of homes and businesses have been
re-built.
Horn of Africa - food distribution to areas suffering from drought.

Water Development - in 2014 HHI drilled 119 wells in Ethiopia,
Haiti, India, Zambia, and Kenya providing clean drinking water.

In 2014 HHI celebrated the drilling of the 639th Water Well.

Agriculture Aid and Education - Trained almost 4,000 men and women
from 10 different nations in simple agriculture strategies and

for playing on a cell phone.
