Oncology Capital Campaign Fund The Oncology Capital Campaign provided funds to complete renovations of the 16-bed inpatient unit used by medical oncology, surgical oncology and palliative care patients Improvements included upgrades to the ventilation system to meet the needs of immunocompromised patients A family waiting area was designed to help family members feel more comfortable during their visit Chairs that transform into twin beds were purchased for patient rooms to provide a place for patient family members to stay overnight These improvements increase the hospital's ability to care for inpatient oncology patients locally The average daily census of the unit is twelve patients

Cardiac Equipment Purchases Funds were provided for the purchase of three pieces of equipment for cardiac care a treadmill, an on-site Automated External Defibrillator (AED), and pediatric TEE probes The exercise treadmill is used for outpatient cardiac rehabilitation to increase the number of patients who can utilize the cardiac rehab equipment at any given time The AED is maintained and used in the emergency room at the hospital A 9T Pediatric Multiplane TEE Probe with a wide-band multi-frequency phased array transducer was purchased for pediatric transeophageal diagnosis and intervention control
