An Amendment to Plan A was adopted effective August 1, 2011, which terminated further accruals (contributions) to the plan. However, the Amendment does allow the accrual of interest on undistributed amounts which will be subject to risk of forfeiture until such time as indicated in the Amendment. Interest earned by Plan A in 2014 amounted to \$83,726 and is not required to be reported in Part II, as Mr. Spezia is not substantially vested in earnings accumulated after July 31, 2011. Plan B was established in 2011. Employer contributions to Plan B during 2014 totaled \$204,000, which is reported in Column C of Schedule J, Part II. Interest earned by Plan B during 2014 of \$43,651 is not required to be reported in compensation in Part II, as Mr. Spezia is not substantially vested in Plan B.
