Franklin County Humane Society- Offers temporary shelter and facilitates adoption of homeless dogs and cats; provides financial assistance for sterilization of pets for low-income families.

Franklin County Salvation Army- Provides food, clothing, funds for medicine, rent, utilities, transportation, back to school supplies for community clients and summer camp for children ages 6-12.

Good Samaritan Ministries of Franklin County- Provides assistance with urgent basic needs for low-income families and individuals.

Haven of Hope, Inc.- Provides crisis counseling, emergency shelter, safety planning, education, resource development and other support services for victims of domestic violence, sexual assault, and stalking.

Raise a Reader- Nurturing the foundation of learning, through reading, by establishing a library in the home of all our children.

New Life TN – To foster, develop, promote, and operate a combination of formal programs, services, and appropriate support over a sustained period that will maximize the quality of life and functional abilities for intellectually and developmentally disabled citizens of Franklin County.

Franklin County Senior Citizens Center – Provides companionship, entertainment, educational, and social opportunities for citizens reaching retirement. Provides opportunities to increase independence and social well being.

Horse Play – Conducts a therapeutic equine assisted program that promotes exercise and social interaction for emotionally, physically, and /or mentally challenged children.

Legal Aid Society – Provides free civil legal assistance to low-income families and elderly on such issues as protecting income, healthcare benefits, domestic violence, tax problems and housing.
