4a (Code:) (Expenses \$ 126,532 including grants of \$ 82,428) (Revenue \$) Empower At-Risk Children - 10/40 Connections works to provide whole-life change, hope, and protection to high-risk children through expanding their educational opportunities. We sustained 17 schools in slum areas which educated and fed 562 children. Funded educational expenses for 22 girls rescued from abusive situations.

4b (Code:) (Expenses \$ 112,136 including grants of \$ 62,389) (Revenue \$) Fight Injustice - 10/40 Connections battles the global epidemic of human trafficking through setting up surveillance stations and recovery homes in Nepal and addresses the lack of health education for women by offering our Voice for the Voiceless curriculum. We prevented human trafficking by rescuing more than 600 women at 6 border stations between Nepal and India. Provided rehabilitation and vocational training for 380 high-risk women in tailoring and beautician skills. Raised trafficking awareness and prevention by hosting 20 street dramas that reached over 2,500 people. 10 seminars of Voice for the Voiceless (women's health and baby development) were presented to 596 participants.

4c (Code:) (Expenses \$ 60,184 including grants of \$ 0) (Revenue \$) Teams - 10/40 Connections prepares Christians to serve both locally and globally through equipping seminars, resource production, and first-hand field experiences. We hosted an anti-trafficking team that worked among 50 rescued women. We hosted a medical team in Nepal that equipped 13 village health workers and served 200+ patients. Facilitated and completed the production of The HOPE video for 30 million speakers of Nepali language. Hosted premiere celebration and distributed 500 DVD copies of The HOPE. Voice for the Voiceless seminar translated into Hindi and Nepali languages. Equipped 520 church planters in 15 trainings. Spoke at various seminars, conferences churches, and universities.
