Depreciation figured: Expected life of paper shredder - 5 years. Straight Line Depreciation = 1 divided by 5 = 20%. Original value of shredder \$72.88 x .20 = yearly depreciation of \$14.58. Therefore: \$72.88 - \$51.03 (3.5 years' depreciation) equals a remaining value of \$21.85.. Expected life of filing cabinet - 10 years. Straight Line Depreciation = 1 divided by 10 = 10%. Original value of filing cabinet \$101.59 x .10 = yearly depreciation of \$10.16. Therefore: \$101.59 - \$35.56 (3.5 years' depreciation) = a remaining value of \$66.03. Expected life of 2011 printer is 5 years. Straight Line Depreciation = 1 divided by 5 = 20%. Original value of Printer \$219.49 x .20 = yearly depreciation of \$43.90. Therefore: \$219.49 - \$87.80 (2 year's depreciation) equals a remaining value of \$131.69. Total depreciated value of all equipment at 2013's end is \$21.85 (paper shredder) + \$66.03 (filing cabinet) + \$131.69 (2011 printer) = \$219.57.

Part II - Line 24 (B): Depreciated value of Paper Shredder (purchased in June 2010 for \$72.88), Filing Cabinet (purchased in June 2010 for \$101.59), & Printer (purchased in Nov. 2011 for \$219.49). Depreciation figured: Expected life of paper shredder - 5 years. Straight Line Depreciation = 1 divided by 5 = 20%. Original value of shredder \$72.88 x .20 = yearly depreciation of \$14.58. Therefore: \$72.88 - \$65.61 (4.5 years' depreciation) equals a remaining value of \$7.27.. Expected life of filing cabinet - 10 years. Straight Line Depreciation = 1 divided by 10 = 10%. Original value of filing cabinet \$101.59 x .10 = yearly depreciation of \$10.16. Therefore: \$101.59 - \$45.72 (4.5 years' depreciation) = a remaining value of \$55.87. Expected life of 2011 printer is 5 years. Straight Line Depreciation = 1 divided by 5 = 20%. Original value of Printer \$219.49 x .20 = yearly depreciation of \$43.90. Therefore: \$219.49 - \$131.70 (3 year's depreciation) equals a remaining value of \$87.79. Total depreciated value of all equipment at 2014's end is \$7.27 (paper shredder) + \$55.87 (filing cabinet) + \$87.79 (2011 printer) = \$150.93.
