Hands on Birmingham (HOB) was established in 1998 with the goal of making volunteering accessible to everyone. HOB's mission is to connect people to meaningful volunteer opportunities. The organization improves and builds community through volunteer engagement and addresses the unmet needs of nonprofit and community organizations through volunteer service.

Hands on Birmingham (HOB) provides essential volunteer labor to several nonprofits and community organizations throughout Greater Birmingham, including Jefferson, Blount, Shelby, St. Clair, and Walker counties. In 2014, HOB provided more than 17,250 hours of labor to support nonprofit and community organizations throughout Central Alabama. These hours were accrued through six major Days of Service and special projects: Project Homeless Connect, Dr. Martin Luther King Jr. (MLK) Day of Service, Family Volunteer Day, 9/11 Week of Service and Remembrance, United Way Day of Action, Bunny Aid, Back-to-School Backpack drive, and community service referrals. Projects consisted of neighborhood revitalizations, park refurbishments, painting, landscaping, constructing community gardens and green spaces, cleaning creeks and rivers, nurturing children, and socializing with seniors. HOB recruited and managed 5,750 volunteers in 2014.

Hands On Birmingham (HOB) conducts one of the largest MLK Days of Service in the country among Hands On Affiliates. This service day has benefitted from a steady growth of volunteer engagement over the past ten years. In 2014, 1,096 volunteers participated in 50 service projects throughout Central Alabama. Volunteers from all walks of life, ages, genders, and races worked together to make a positive impact in their communities. Other notable accomplishments for HOB include the assembly of 3,200 Easter baskets for homeless children through the Bunny Aid program and the distribution of 1,633 backpacks, donated by volunteers, to children in need. Lastly, HOB partnered with the City of Birmingham, the Bloomberg Foundation, Home Depot, and Alabama Power to revitalize twenty Birmingham neighborhoods through the Cities of Service initiative.

Project Homeless Connect (PHC) is an annual event started in 2008 to address social, financial, hunger, and health issues impacting the homeless community in Birmingham. PHC provides crucial services year-round, which climaxes with the annual PHC event held annually in March. In partnership with One Roof, the City of Birmingham, Jefferson County Department of Health, and over 40 community partner agencies and local businesses, anyone struggling with homelessness can attend PHC and receive any and all services available, free of charge, in one day. These services include anything from resources for housing and employment, resources to address hunger and nutrition, legal services, financial planning, haircuts, counseling, care kits, clothing, and a plethora of healthcare services including medical, dental, and HIV testing. HOB's role in this event is to coordinate and train volunteers that serve as Smiling Faces Client Guides. These volunteers are paired one-on-one with each homeless client to serve as their host and guide throughout their time at PHC. In 2014, over 900 clients were served at PHC with 1,030 volunteers directly paired with a homeless client. Without these volunteers, the event would not be a success year after year. PHC volunteers are instrumental to help increase the capacity of all the organizations providing services to the clients. HOB's goal is to guide the clients through the process and help them meander through a vast array of helpful services, treat them with dignity and respect that they deserve, and to make their day as seamless as possible by simply being a friend. Though services are provided in one day, these services help the homeless population across the continuum of their situation. HOB volunteers devoted 2,100 volunteer hours to PHC.
