


THE FINANCE CHAIR PRESENTS THE CFWA WITH AN AUTHORIZATION FOR DISBURSEMENT ALONG WITH THE INVOICE AND OTHER PAPERWORK. THE CFWA ISSUES A CHECK REQUIRING TWO SIGNATURES.

ALTHOUGH THERE HAVE BEEN SMALLER CONTRIBUTIONS TO THIS FUND, THERE HAVE BEEN SIX MAJOR CONTRIBUTORS TO THE LTRC ACCOUNT. EACH HAD DIFFERENT STIPULATIONS ON HOW THE FUNDS WERE TO BE SPENT AND ACCOUNTABILITY RECORDS WERE FILED.
