"The Foundation supports agencies engaged in social services, health, cultural enrichment, education and the environment. The Foundation accepts grant applications from agencies which serve South Sarasota County residents and which meet IRS Code Section 501(c)(3) requirements."

There were no Grants made during the short period July 1, 2014 to December 31, 2014.

Grants are usually made in the month of April. The money to pay these grants is raised through membership donations, the bulk of which comes in during the fourth calendar year quarter and from fundraising events such as the Celebrity Golf Classic, the Royal Ride and the Fashion Show.

Only the Royal Ride event took place in the short period July 1, 2014 to December 31, 2014. The two other major fundraisers will occur in the first calendar year quarter. There are, however, some receipts and expenses in this period for the Celebrity Golf Classic.

Fundraising activity generated Gross Receipts of \$54,287 offset by expenses of \$13,212.

Other than two clerical positions which are part-time, no salaries or any other kind of payments are given to anyone who is involved in the Foundation. The expenses that are incurred are all of a type that anyone would associate with these kinds of activities.

We have a small office which we rent for \$100 a month, out of which all Foundation functions are carried out. The entire concept of "Program Service Accomplishments" does not relate to a small Foundation such as the Plantation Community Foundation.

The members of the Foundation are those individuals and families who pay the annual membership donations. All "elected" positions have to put in a lot of time, so there are no real elections. We often have trouble finding volunteers to fill all of our positions, so the concept referred to in this Form is not valid for our organization.

All of our volunteers are unpaid retirees with basically no background in exempt organization tax law. This return was passed around and all Directors had a chance to look at it and ask any questions they may have had to the volunteer tax preparer. The preparer also met and reviewed Form 990 with the Foundation President.

Every year, the Foundation pays a fee and registers with the Florida Department of State, Division of Corporations. As far as we can determine, a copy of our Form 990 has never been requested by the State of Florida.
