For 25 years, Chris Evert Charities has partnered with the Ounce of Prevention Fund of Florida, a public-private partnership that makes a measurable difference in the lives of Florida's vulnerable children through grant funding to service providers from Key West to Pensacola. Chris Evert is a long-standing and active member of the Ounce of Prevention Fund's Board of Directors and an outspoken advocate for the organization and its programs. Chris Evert Charities also funds Vitas Gerulaitis Memorial Scholarships to help women who are current or past participants in the Ounce of Prevention Fund's programs. To date, 39 two-year college scholarships have been awarded.

Proceeds from Chris Evert Charities' annual fundraiser support operations and fund a variety of innovative, community-based programs serving at-risk families. The Ounce of Prevention Fund's Board of Directors' program committee, with input from the Florida Department of Health as a major public funding partner, selects grant recipients based on organizational priorities. The timing and amount of grants is negotiated by the Ounce of Prevention Fund's Vice President and Director of Program Administration and approved by its Board of Directors.
