Rocky Mountain Research & Prevention Institute (RMRPI) was established in 2002 to support programs that have a common
interest to benefit the health and welfare of children. These programs include a summer education program for at risk youth, suicide
prevention coalition of many non-profits in the state of Colorado, and a license plate program that generates funds and awareness
for programs throughout the state of Colorado

Suicide Prevention Coalition of Colorado is a coalition of non-profit organizations in the state of Colorado dedicated to suicide
education and prevention. This coalition is a program administered by RMRPI. In 2013 the coalition provided educational programs
and conferences/webinars. There was a large increase in the revenue in 2013 due to SPCC/RMRPI agreeing to administer the funds
and manage the Bridging the Divide conferences going forward. This is a statewide suicide prevention conference that brings
speakers to the state to create dialogue around many suicide related topics. The program had formerly been fiscally managed by
Colorado State University, but they turned over the funding and management to SPCC/RMRPI as it was more cost effective.

4b (Code: AY4S) (Expenses \$ \$12,291 including grants of \$) (Revenue \$ \$18,624)
Aurora Youth 4 Success is a program provided to approximately 150 at-risk youths in the city of Aurora. The program offers 15
different courses for the kids to study, ranging from cosmetology, business, art, theater, computer skills, and culinary arts. The
program is offered at little or no costs and is funded through private donations. Each day during the program a lunch is provided
with various speakers discussing possible career paths.

4c (Code: Kids1st) (Expenses \$ -9,410 including grants of \$ -7,250) (Revenue \$ \$9,560)
Colorado Kids 1st is a program founded and operated by RMRPI. In 2013 the program generated \$9,560 through \$30 donations to
obtain a certificate that allowed people to receive the Colorado Kids 1st License plate from the State Motor Vehicles office. Of the
amount of funds raised, \$7,250 was granted out to various non-profits in the State of Colorado through small grants (maximum eligibl
amount is \$1,000). These funds are distributed to help administer various children's injury prevention programs. 2013 recipients
included The Boys and Girls Club of Pikes Peak region, the HOPE center, Morgan Adams Foundation, Qualistar Colorado, RIHEL,
and the Ronald McDonald House of Southern Colorado.
