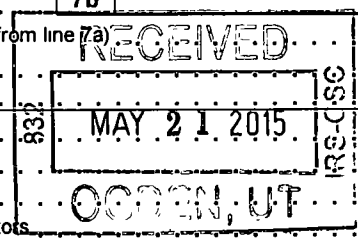



During 2014, the Santa Fe Group continued to partner with the American Dental Hygiene Association to develop recommendations from the September 2013 joint symposium. The two organizations completed a white paper sponsored by HRSA. The Santa Fe Group members met in February 2014 to establish goals and priorities for the next few years. The members agreed to establish a Founders Fund program. In 2014, the group established goals and structure of the program and solicited several corporate partners to participate in 2015. The Santa Fe Group engaged in meetings with several organizations to discuss strategies to address important issues related to oral health workforce, policy, and education.
