This process includes an analysis of whether the position the Cooperative takes with regard to a particular item of income would meet the definition of an uncertain tax position under ASC Topic 740. As a result of the evaluation made for 2014 of the components of the annual test for maintenance of its tax-exempt status, the Cooperative takes the position for the year ended December 31, 2014, that it continues to qualify as a tax-exempt not-for-profit entity under section 501(c)(12) of the Internal Revenue Code of 1986, as amended.
