2014 AITo Program Service Accomplishments"Maleos have a right to live, too," said Taima villager Sudiarto Yusup on March 1, 2014, explaining why he had chosen, along with eighteen other village leaders, to sign a new interim agreement with AITo to collaborate in protecting the endangered maleo birds nearby nesting ground And as if in relief and celebration of the new agreement, on March 31, a record fifty-six maleos were recorded at the nesting ground at one time--the highest numbers seen since data recording began in 2006, and likely more maleos than have been seen in decades The Long Arm of the Law Gets LongerAITos Law Enforcement Outreach program has proven so popular among officials in Tompotika that on request of the district head, the program was recently expanded into the Balantak Selatan district AITos previous work with officials from other districts has produced a small cadre of experienced and committed local experts Now, AITo is facilitating these experts in taking a lead role in mentoring their peers on the whys and hows of wildlife law enforcement Its working in Teku village, sea turtle survivorship has more than quadrupled since the Law Enforcement program began in 2012 These maleos will have children and grandchildren All maleo poaching has ended, AITo has a new long-term contract to collaborate in their management, a second nesting ground is now being protected, and maleos have been breeding in record numbers! Wahyu and friends helped thousands fall in love with conservation AITo's youth drama troupe brought a funny, hard-hitting show about maleos and sea turtles to 9 villages throughout Tompotika Audiences, village leaders, and participants all loved it Afterwards, sea turtle poaching dropped to its lowest levels ever
