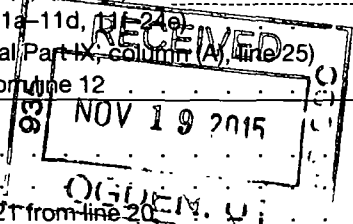

Of those 10,000 provided sessions, approximately 25% are provided for little or no fee. The demand for the services offered through CFCC & Associates, Inc. continues to increase and we are now providing services through three outpatient treatment centers and two equine assisted treatment locations.

Public education services. CFCC provides educational services to many community organizations, not for profit groups such as MOPS groups, churches, doctor's offices, and many other non-profit organizations at little or no fee.
