## 2014 Annual Report

### The Taylor Charitable Trust

In 2014 our Trust experienced a more “normal” year. No Trustees died, no major projects were undertaken; our path was a continuum derived from previously-made decisions. Our financial support was focused on our Adams project at The University of North Carolina at Chapel Hill and the Vestavia Hills Baptist Church. The UNC expenses totaled \$79,000, consisting of a \$40,000 outright donation to UNC, \$35,000 in grants to advanced graduate students (3) and \$4,000 paid to judges who evaluated the student papers (personally, I thought the student essays were better than the faculty ones from 2013!). VHBC was given \$88,500; the general budget received \$32,000, and \$56,000 went to fund special missions projects and a renovation of our rear parking area made possible by the removal of a temporary classroom trailer.

Our relationship with UNC has entered a transition period that entails some uncertainties. Dr. Eve Duffy left UNC to assume new duties at Duke University. She resigned our board and was replaced by Dr. Max Owre, who assumed her Chapel Hill duties on an interim basis. Subsequently, the University decided a dual oversight of The Program in Humanities and Human Values might best advance its educational mission, with Max supervising its daily tasks and programming support and Dr. Lloyd Kramer, Professor of Intellectual History at UNC, providing faculty guidance.

On the weekend of May 15, 2015, Dr. Owre, Dr. Kramer, and Mr. Frank Kiker (an Advisory Board member for the Program) came to Birmingham to visit with Marlene and me here at our home. Having never met Dr. Kramer, we assumed he wanted to “check us out.” UNC suffered severe financial distress, as did all of state government, when major budget cuts were required due to falling tax receipts. N.C. major industries—tobacco, furniture manufacturing, and textiles—and employers were decimated by competition, regulation and severe recession. Not being degree granting, the Program’s financial future was in doubt and underwent severe cutbacks. Its saving element was that it could generate some of its own funding from seminar fees and, of course, from The Taylor Charitable Trust. Happily, under Max’s leadership, the seminar fee income has made the Program almost self-sufficient and its services are so valuable to alumni that its future is no longer in doubt.

As it turned out, our UNC guests had more than a “get acquainted” purpose in mind. On Saturday morning we were told that UNC would no longer be a co-sponsor of the Adams essay competition after the one for this year. Instead, they proposed to change the educational focus to the whole of Maynard Adams’ life and career as a humanities professor, sponsoring an annual symposium with a prominent keynote speaker, attenuated by smaller seminars more narrowly focused on Maynard’s ideas. They hoped I would pledge a \$100,000 endowment to annually fund keynote speaker fees/expenses, expected to be about \$5,000 per year. Their proposal involved many more details too extensive for this report, but they emphasized to me that financial incentives had a “taint” on free and open scholarly debate and that was part of why UNC’s philosophy department would not sign on as a co-sponsor of our Adams project, even though it honored one of UNC’s “brightest and best,” and one of their own. I emphasized in reply that removing any “taint” was a worthy goal, but that there were many stars in the humanities firmament, and that despite Maynard’s exemplary life as a humanitarian citizen, teacher and scholar, Maynard was unique only because of one key philosophical premise, namely, that feelings and emotions are knowledge yielding, and like any dedicated logician, he provided compelling arguments in defense of his proposition.

Philosophical naturalism has remained the dominant world-view among philosophers and most of academia for at least 300 years now, even though much of it flies in the face of common sense. Maynard argued that the epistemological foundations of naturalism were deficient, and that its deficiencies made the humanities valueless to educated persons, having no utility in dealing with the real world, despite their artistic merit. So I emphasized to Dr. Kramer and Max that it is critical that any different *modus operandi* keep focus in the future on what made Maynard Adams a unique scholar in western civilization. Although my personal commitment is to champion Maynard's epistemological ideas about value experiences, all I (and this Trust) can expect is that his ideas get a fair hearing; they must stand or fall on their own merit. So I will cooperate with UNC's new plan, but will insist as best I can that its primary focus be on the "jugular" of Maynard's life.

Returning to a financial review of 2014 for our Trust, we began the year with \$3,440,000 on hand and ended the year with \$3,466,122 in assets. During 2014 we disbursed \$169,900, and on a net basis earned an approximate 5.7% return on capital. Cumulatively, our Trust to date has distributed \$1,916,822.96 to needed and worthy projects that would not have been possible without our support. I anticipate that in the next two or three years disbursements will exceed our income, so we will try to focus more on principal growth than on income generation. Recent market behavior may frustrate that objective, however.

Marlene and I thank all of you for your service as Trustees, and we wish for you and your families good health and good fortune in 2015.
