OPERATING AS OPEN ARMS CLINIC (OAC), 3,984 PATIENT VISITS WERE PROVIDED FOR THE YEAR (AVERAGE OF 332 VISITS PER MONTH) TO 1,481 INDIVIDUALS IN A PATIENT-CENTERED MEDICAL HOME ENVIRONMENT TO THOSE WHO WOULD OTHERWISE HAVE NO ACCESS TO MEDICAL CARE. PATIENTS ARE PROVIDED PRIMARY CARE AND SPECIALTY VISITS IN DERMATOLOGY, RHEUMATOLOGY, UROLOGY, PODIATRY AND GYNECOLOGY, AS WELL AS ENROLLMENT SUPPORT FOR NATIONAL PHARMACEUTICAL ASSISTANCE PROGRAMS, NUTRITION GUIDANCE, AND ASSISTANCE WITH ISSUES RELATED TO CONTROLLING DISEASE PREVALENT AMONG PERSONS SOCIO-ECONOMICALLY DISADVANTAGED SUCH AS DIABETES AND HEART DISEASE. THE OPERATION OF THE CLINIC IS VERY MUCH A COMMUNITY COLLABORATION WITH VOLUNTEER DOCTORS PROVIDED BY THE OKLAHOMA COUNTY MEDICAL SOCIETY, SUPPORT SERVICES

OPERATING AS DEACONESS PREGNANCY AND ADOPTION SERVICES, (DPAS) PLACED 18 CHILDREN IN SAFE, NURTURING HOMES, CONDUCTED 439 PRE-ADOPTION AND 271 POST-ADOPTION COUNSELING SERVICES AND PROVIDED INFORMATION AND SUPPORT TO 843 INDIVIDUALS. BUTTERFIELD CONTINUES TO PROVIDE AN EXTENSIVE TWO-PRONGED INITIATIVE FOCUSED UPON IMPROVING ACCESS TO PRIMARY MEDICAL CARE IN THE STATE OF OKLAHOMA. MORE THAN \$4,383,676 IN GRANT FUNDING WAS DISTRIBUTED TO SUPPORT THE THIRD YEAR OF THE BUTTERFIELD STANDARD OF CHARITABLE CARE PILOT PROGRAM, A PROGRAM AIMING TO SHIFT THE PARADIGM OF DELIVERY OF CHARITABLE MEDICAL CARE IN OKLAHOMA. THE END RESULT OF THE THREE-YEAR PILOT PROGRAM WILL SEE A MORE THAN 465% INCREASE IN THE NUMBER OF CHARITABLE PRIMARY CARE MEDICAL APPOINTMENTS AVAILABLE TO THE MEDICALLY VULNERABLE IN OUR COMMUNITY. TO ADDRESS THE DAUNTING SHORTAGE OF PRIMARY CARE PROVIDERS, WHICH CONTINUALLY PLACES OKLAHOMA AMONG THE MOST STATE-CHALLENGED, \$47,482 WAS DISTRIBUTED TO FUND EDUCATION AND SUPPORT ACTIVITIES, WITH A GOAL TO
