The STAR Project provides reentry services to individuals exiting incarceration within Washington State. Incorporated as a 501(c)(3) charitable organization in 2004, STAR has served over 700 ex-offenders and their families through best practices for offender re-entry, including case management, housing support, and group cognitive behavioral therapy and mentoring. Ex-offenders with felony convictions fall into the designation of those persons who are at high risk of chronic homelessness as outlined by the Department of Housing and Urban Development (HUD). As such, STAR Project works with landlords to secure adequate, appropriate housing for clients. Further, as the median income for STAR clients is \$187 per month the first weeks of services, STAR actively pursues grant and donation funding for housing units. Rental/shelter assistance is usually provided for up to 90 days, during which time clients work with a case manager on securing either employment or beginning education, to secure income. To aid ex-offenders in building life skills which will aid them in transition and remaining out of the criminal justice system, all clients participate in personal development programs. These include weekly Moral Reconation Therapy (MRT), a best practices cognitive behavioral program, weekly support groups centered around a meal, and being paired with a mentor. Clients also receive employment or education support through STAR. In 2014, 76% of STAR clients were fully self-supporting within 90 days of enrollment for services. This comprehensive, wrap around service model has resulted in a recidivism rate of just less than 6% following the first year of release, in contrast to the state average for the years 2004-2009 of over 12%.
