Rehabilitation of injured/sick sea turtles. Care and placement of non-releasable turtles. Healthy sea turtles are released back into the wild. Non-releasable sea turtles are used for educational purposes. In 2014 we had 394 sea turtles stranded. Of these, 302 were live turtles that were rescued and released, 92 were dead, 28 died, and the remaining 1 is still being treated in rehab. STI is still caring for 7 non releasable turtles. No turtles were transferred to other facilities in 2014.

Conservation - support of sea turtle conservation efforts worldwide. Sponsor of local (South Padre Island and Boca Chica Beach) beach patrols and South Padre Island corral for protection of sea turtle nests and eggs. In 2014, 23 nests were recovered. 2045 hatchlings were released. There were 7 public releases. Last summer there were 8 interns selected from approximately 400 applications.

Education - educational presentations to school group and public to inform them of endangered status of sea turtles and how to support conservation efforts. In 2014 there were approximately 100,000 visitors to the facility. For education there were presentations to 12,317 school children both at the facility and with outreach programs. Last summer's kid's camp had 52 participants.
