Vendors are local artisans/crafters that have been chosen to participate in the event. The event is a two-day event. Vendors pay a fee to participate and all of the sales are retained by the vendor.

A small fee (\$3.00 for both days) is charged as admission to the event. Attendance and vendor participation have been declining over the past couple years.

This is one of two major fundraising events held by the Lincoln Center Support League.

**4b** (Code: ) (Expenses \$ 2,337.75 including grants of \$ 0) (Revenue \$ 3,280.00)**GALLERY OF TREES** - a display of holiday decorated trees provided by local business owners. Also on display are 3 ft. trees provided by the Support League to local artisans and community members. The small trees are decorated and are then in a "silent auction" which generates funds for the Support League. The event is open for 7 days and there is no admission charge.

This is the second major fundraising event held by the Lincoln Center Support League.

**4c** (Code: ) (Expenses \$ 10,000 including grants of \$ 5,000) (Revenue \$ 5,000)**The Children's Summer Series** is a program offered once a week for five weeks during the summer. Professional actors/musicians/entertainers are hired to present an hour long program tailored to 2-12 year old children. There is no fee for attending. The grant covered \$2,500 of expense with the remaining \$2,500 coming from Support League funds.**The Educational Outreach** program received a grant of \$2,500 to cover expenses for a presentation of "Story Pirates" to three local schools and then a presentation at the Lincoln Center.
