EMI is a technical resource for other mission organizations around the world, both in development and disaster relief contexts In 2014, EMI worked on 71 projects in 22 countries, sending out teams that totalled 162 volunteers and 58 interns These projects represent design work that will enable the construction of hospitals, schools, orphanages, water pipelines, ministry centers, youth camps, churches and places to live for some of the poorest people in the hardest to reach corners of the world From helping establish clean water stations in the typhoon aftermath in the Philippines, to helping design a school in Uganda, to helping restore miles of a failed water pipeline in rural Malawi - EMI teams provided technical and strategic design assistance to many clients in a variety of critical times and places
