In 2014, Durango Education Foundation continued to concentrate on giving financial support to Durango School District 9-R ("9-R") classrooms and to community organizations which serve 9-R students Every school in the district received funding from DEF efforts DEF hosted an extraordinary fundraising event, the Community Action for Education (C A F E) campaign,to raise money for schools and also to draw public attention to the severe school funding budget cuts imposed by the State of Colorado and the effect on teachers, students and classroom needs, DEF took no administration fees beyond the direct costs of the campaign and the money was given to the schools for their discretionary use with very minimal restrictions Separate from C A F E , DEF funded grants to teachers and community organizations to support a range of academic programs, materials and technology needs throughout the school district Grants funded such needs as library books, "common read" books and author visit, a pilot program for teaching reading to primary grade English Language Learners, classroom art supplies, iPads and laptops, financial literacy program, vocabulary curriculum materials, and a sound system for a multipurpose room In addition, DEF administered 10 scholarships,provided grants for performing and visual arts education, and assisted various student academic competition teams with travel expenses
