WHEAT's education programs provide awareness, ongoing training and tools for action in the fight against hunger including
workshops, presentations, skill building. Programs include the Norma Johansen Hunger Library providing resources of all kinds,
free of charge, for book discussion, motivating youth, teaching a class and more. WHEAT's Training and Mentoring program provide
management level training including on-the-job, workshops, personal and professional development seminars in volunteer, retail
and office management to people in poverty. This job training gives the participants marketable skills to become gainfully
employed. Job Training and Mentoring also includes WHEAT's Youth Leadership programs, providing mentors to youth at
risk, while they receive job experience and attend workshops on career development and future educational opportunities.
Recipients receive TANF and/or are Arizona low income residents. WHEAT graduated 242 individuals from Management Training,
sponsored 123 Youth in the Seasons of Service Youth Leadership program, provided SNAP outreach at 57 locations statewide,
and presented 143 lectures and workshops in 2014.

The Clothes Silo and Workwear for Men projects provide free, professional clothing to men and women in need who are entering
or re-entering the workforce. Serving 6,915 women and 911 men in 2014, the program provides clothing, as well as personal
shoppers who give the clients special attention to find just the right outfit. The programs also provide special networking
opportunities and additional workshops for the clients throughout the year. The clothing is also available for much-reduced prices
to the public to support the expenses associated with the programs, as well as to provide a great source of professional wear for
those employed who have little extra to spend business attire. Recipients receive TANF and/or are Arizona low income residents.

Another of WHEAT's major empowerment programs includes its fair trade initiative, the Hand to Hand Project, featuring fairly traded
handicrafts from artisans in 43 countries, including the United States. Purchases of these quality items help the artisans become
self sustaining, able to feed, clothe, shelter and educate themselves and their families. Fair trade is a very successful and positive
way to fight hunger and poverty, worldwide. WHEAT empowered 56 artisans and their families to self sufficiency in 2014.
