Whether partnerships, joint ventures, and arrangements with management organizations conform to the Foundation's written policies, are properly recorded, reflect reasonable investment or payments for goods and services, further the charitable purposes, and do not result in inurement, impermissible private benefit or in excess benefit transaction.
3. The Foundation will periodically review the policy as a whole and discuss its provisions with all employees who have any responsibility for purchasing or expenditure of funds.
