In 2014, DBM gave away 5.76 million pounds of food, served over 250,000 people through over 90 community and ministry partners. In August, we began picking up milk and produce from 25 schools that was destined for the trash. This added approximately 1 million pounds of fresh milk and produce that we were able to give away to needy families and Seniors served by Meals on Wheels. We also received funding to begin our Commercial kitchen in order to expand our feeding programs and funds for warehouse racking and a new forklift. New partners are coming along side to help develop our facility into a one-stop community center providing help and hope for those living in poverty and the under-served.
