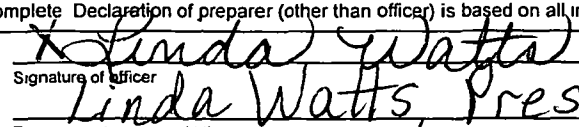

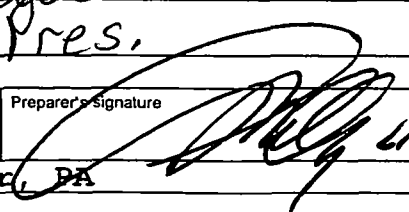

Florida's Hometown USA Program, Inc. is a non-profit corporation formed to involve more students in the area of volunteering and to be recognized as a leader in caring for children and youth and servicing people. Our goal is to educate the youth of Florida on the values of volunteer work and inspire them to make a difference in the lives of their neighbors through volunteer commitment. We encourage and work with students who have a desire to volunteer and to promote pride in their community by active involvement. We stress to the youth to take time to visit and give of their time to make someone else's day a little brighter. The focus of our volunteer work is with children, youth and the elderly offering support to those who have been abused or neglected.

Students commit to giving of their free time in this community organization as a volunteer service to help others. Another outreach we promote is to connect with adults by volunteering with the elderly. This area promotes the value of the youth as they spend time with the elderly. Often, the entire family of the student gets involved and can be a big part of an elderly person's life.

Students in this program are elementary through college age. If children are involved in volunteering at an early age and are taught to show love and concern for others, it will stay with them forever. Our program meets the community needs by providing food, clothes, personal care items, and assistance where needed. By doing this we are strengthening our educational program as we stress to the children and youth the importance of helping others.

Our organization is partnered with 32 facilities throughout Florida to work with needy children, teens, and the elderly. The visits to the elderly help brighten the day of many lonely people. Some have no family or visitors and just a smile and a hug are all they want. The entertainment for the elderly is always enjoyed and they love to sing along. Some of the residents at the nursing homes are happy just to see and talk with a young person. Giving of the gifts to children's hospitals teach the students to share and have compassion for others less fortunate.

Throughout the year, we have fundraisers to raise money to buy the things needed at the facilities we are partnered with. We supply personal care items – shampoo, soap, deodorant, shaving cream, toothpaste, etc. to the shelters, clothes to the shelters and to the needy.
