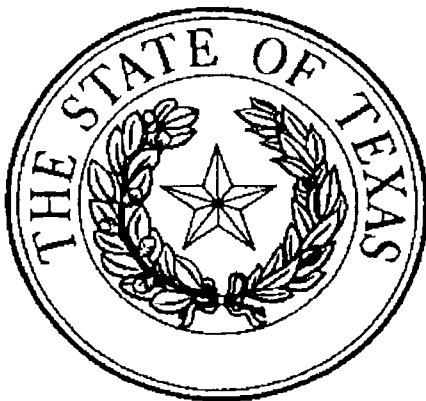

Pursuant to Chapter 10 of the Texas Business Organizations Code ("TBOC"), and the title applicable to each domestic filing entity identified below, Hugworks, a Texas nonprofit corporation ("Hugworks"), and KidLinks Foundation, a Texas nonprofit corporation ("KidLinks"), hereby submit this Certificate of Merger for the purpose of effecting a merger of KidLinks with and into Hugworks (the "Merger"):

1. The names, organizational forms, states of organization and file numbers issued by the Texas Secretary of State for each organization that is a party to the merger are as follows:

2. Hugworks will survive the Merger, and KidLinks will not survive the Merger.

3. An Agreement and Plan of Merger, dated December 30, 2014, by and among Hugworks and KidLinks (the "Plan of Merger"), which provides for the merger of KidLinks with and into Hugworks, with Hugworks being the surviving nonprofit corporation of the Merger, and which sets forth the terms and conditions of the Merger, has been approved as required by the TBOC which is the law of the jurisdiction of formation of Hugworks and KidLinks and by the governing documents of Hugworks and KidLinks.

4. The signed Plan of Merger is on file at the principal place of business of Hugworks at the address specified above. On written request, a copy of the Plan of Merger will be furnished without cost by Hugworks as the surviving entity to any member of any entity that is a party to the Plan of Merger.

5. The Plan of Merger effected changes or amendments to the Certificate of Formation of Hugworks. The changes or amendments to Hugworks' Certificate of Formation are stated below:

A. Article I of the Certificate of Formation is amended to change the name of the Corporation and shall read in its entirety as follows:

"The name of the corporation is KidLinks."

B. A new Article VIII is added to the Certificate of Formation to provide for the amendment to the bylaws of the corporation and shall read in its entirety as follows:

"The power to adopt, alter, amend or repeal the Bylaws of the corporation and the power to amend or restate the Articles of Incorporation shall be vested exclusively in its Board of Directors."

C. A new Article IX is added to the Certificate of Formation to provide for indemnification of officers and directors and shall read in its entirety as follows:

"The Corporation shall indemnify any person who was, is, or is threatened to be made a named defendant or respondent in a proceeding (as hereinafter defined) because the person (i) is or was a director or officer of the corporation or (ii) while a director or officer of the corporation, is or was serving at the request of the corporation as a director, trustee, officer, partner, venturer, proprietor, employee, agent or similar functionary of another foreign or domestic corporation, partnership, joint venture, sole proprietorship, trust, employee benefit plan or other enterprise, to the fullest extent that a corporation may grant indemnification to a director of nonprofit corporations under the Texas Business Organizations Code, as the same exists or may hereafter be amended. Such right shall be a contract right and shall include the right to be paid by the Corporation expenses incurred in defending any such proceeding in advance of its final disposition to the maximum extent permitted under the Texas Business Organizations Code, as the same exists or may hereafter be amended. If a claim for indemnification or advancement of expenses hereunder is not paid in full by the corporation within 90 days after a written claim has been received by the corporation, the claimant may at any time thereafter bring suit against the corporation to recover the unpaid amount of the claim, and if successful in whole or in part, the claimant shall be entitled to also be paid the expenses of prosecuting such claim. It shall be a defense to any such action that such indemnification or advancement of costs of defense is not permitted under the Texas Business Organizations Code, but the burden of proving such defense shall be on the corporation. Neither the failure of the corporation (including its Board of Directors or any committee thereof, or special legal counsel) to have made its determination prior to the commencement of such action that indemnification of, or advancement of costs of defense to, the claimant is permissible in the circumstances nor an actual determination by the corporation (including its Board of Directors or any committee thereof, or special legal counsel) that such indemnification or advancement is not permissible shall be a defense to the action or create a presumption that such indemnification or advancement is not permissible. In the event of the death of any person having a right of indemnification under the foregoing provisions, such right shall inure to the benefit of such person's heirs, executor, administrators and personal representatives. The rights conferred above shall not be exclusive of any other right which any person may have or hereafter acquire under any statute, bylaw, resolution of directors, agreement or otherwise. The corporation may additionally indemnify any person covered by the grant of mandatory indemnification contained in this Article to such further extent as is permitted by law and may indemnify any other person to the fullest extent permitted by law. The corporation may purchase and maintain insurance or a similar arrangement (including, but not limited to, a trust fund, self-insurance, a security interest or lien on the assets of the corporation, or a letter of credit, guaranty or surety arrangement) on behalf of any person who is serving the corporation (or another entity at the request of the corporation) against any liability asserted against such person and incurred by such person in such a capacity or arising out of status as such a person, whether or not the corporation would have the power to indemnify such person against that liability under this Article or by statute. Notwithstanding the other provisions of this Article, the corporation may not indemnify or maintain insurance or a similar arrangement on behalf of any person if such indemnification or maintenance of insurance or similar arrangement would subject the corporation to income or excise tax under the Internal Revenue Code."

D. A new Article X is added to the Certificate of Formation to provide for limiting the liability of directors of the Corporation and shall read in its entirety as follows:

"A director of the corporation shall not be personally liable to the corporation for monetary damages for any act or omission in such director's capacity as a director, except that this Article does not authorize the elimination or limitation of the liability of a director

to the extent the director is found liable for: (i) a breach of the director's duty of loyalty to the corporation; (ii) an act or omission not in good faith that constitutes a breach of duty of the director to the corporation or an act or omission that involves intentional misconduct or a knowing violation of the law; (iii) a transaction from which the director received an improper benefit, whether or not the benefit resulted from an action taken within the scope of the director's office; or (iv) an act or omission for which the liability of a director is expressly provided by an applicable statute. The foregoing elimination of liability to the corporation shall not be deemed exclusive of any other rights, limitations of liability or indemnity to which a director may be entitled under any other provision of the Articles of Incorporation or Bylaws of the corporation, contract or agreement, vote of the directors, principle of law or otherwise. Any repeal or amendment of this Article shall be prospective only, and shall not adversely affect any limitation on the personal liability of a director of the corporation existing at the time of such repeal or amendment. In addition to the circumstances in which a director of the corporation is not personally liable as set forth in the foregoing provisions of this Article, the liability of a director shall be eliminated to the full extent permitted by any amendment to the Texas Business Organizations Code (or any successor statute(s)) hereafter enacted that further eliminates or permits the elimination of the liability of a director."

E. A new Article XI is added to the Certificate of Formation to provide for action by non-unanimous consent of the directors and shall read in its entirety as follows:

"Any action required or permitted to be taken at any meeting of directors or committee members may, in the manner provided in Section 22.220 of the Texas Business Organizations Code, be taken without a meeting, if a consent or consents in writing setting forth the action so taken shall be signed by a sufficient number of directors or committee members, as the case may be, as would be necessary to take that action at a meeting at which all persons entitled to vote on the action were present and voted. Prompt notice of the taking of any action by the directors or a committee without a meeting by less than unanimous written consent shall be given to those directors or committee members who did not consent in writing to the action."

6. Hugworks will be responsible for the payment of all fees and franchise taxes, if any, of KidLinks and will be obligated to pay such fees and franchise taxes, if any, if the same are not timely paid.

7. The Certificate of Merger shall be effective as of 11:59 p.m. on December 31, 2014.
