Equest provides equine assisted activities and therapies to children and adults with physical, cognitive and emotional disabilities in North Texas Equest served 246 unduplicated clients and delivered 5,126 rider hours during the year ended December 31, 2014 Equest has experienced an average of 16% annual growth of program participants since 2011 The annual cost per rider is approximately \$6,500 On average, 86% of all program expenses for the general rider population are underwritten In 2014, the majority of program growth was in the veterans program where 100% of the expense is underwritten Equest was the first, and continues to be one of the largest, non-profit therapeutic riding centers in Texas Through our program, our clients see improvement in muscle tone, strength, flexibility and balance Additionally, our horse therapy allows our riders to achieve cognitive, social and emotional development resulting in increased self-esteem, concentration and independence Equest’s therapeutic riding opportunities are a powerful catalyst to profound accomplishments in the lives of our riders and their families
