	Dallas CASA trains and supervises community volunteers who gather information and make recommendations that help judges decide the best possible outcomes for children who have been removed from unsafe homes and are living in protective care. Almost 4,400 abused and neglected children are in protective care each year in Dallas County. In 2014, Dallas CASA served more than half of these children with 771 volunteers and 37,792 direct service volunteer hours. Dallas CASA trained and supervised these volunteers with a total staff of 64 at year-end.
