The Home has four houses which can house up to 52 women and children. However, the capacity for 2014 was only 32, as one house was under renovation. For 2014, 74 (unduplicated) women and 27 (unduplicated) children were provided with shelter, therapy, and development of skills to become self-sufficient. These numbers included 51 single women and 16 families (50 individuals).
