MISSION & PURPOSE In recent years, there has been a sharp increase in the number of homeless families with children The number of homeless families with children has increased 36 percent since 2010 as reported by the Metro Dallas Homeless Alliance On any given night in Dallas County alone, more than 1,100 children fall asleep in homeless and domestic violence shelters Of the homeless children, 67 percent are under the age of nine and 29 percent are infants and toddlers under the age of three years In 2012, 42 percent of the service agencies surveyed reported that they had to turn away homeless children because they were operating in capacity Since 1989, Captain Hope's Kids has been dedicated to helping homeless children with time, money, and in-kind donations We are the only agency that actively solicits donations and funds for the sole purpose of providing critically needed items to homeless children, from birth to age 17 In 2014, Captain Hope's Kids partnered with over 47 homeles
